### VISION:

## IN THE PAST ...

In 2009, we developed a three-year plan to execute in 2010 – 2012 that focused heavily on three strategic areas; upgrades to (1) the electrical distribution system and (2) internal technologies, and (3) the addition of substations on the electrical system. We soon began the physical construction of desperately needed distribution substations and the deployment of a new metering system. While we work to improve our system reliability through the substation builds and related system upgrades, the metering system, once installed, will work

in conjunction with technology upgrades to our future outage management system. Combined, these elements will allow us to improve our management of system interruptions and, over time, trouble shoot and restore service in a much more proactive and expedient manner. Other technology upgrades include a Geographical

Information System (GIS) to improve the mapping of system device connections, which will allow the outage management system to pinpoint outages quickly and accurately. We also installed a fiber communication network to connect our Battle Ground and Linden offices and some of our larger substations. This system will provide a redundant communication structure, increase reliability, and exchange system data at vastly improved speeds. While these projects will improve our ability to manage our distribution system in a more proactive manner, they will also give our members detailed data allowing them to better manage their energy consumption. In other business functions, the leadership team and board of directors looked very hard at some of the ancillary services offered by the

cooperative. The Board decided to exit ventures that were not aligned with our organizational mission and were not operating as predicted from a service or financial standpoint. In conjunction with our power supplier, Wabash Valley Power Association (WVPA), Tipmont also participated in energy efficiency initiatives and offered members various discounts for efficiency upgrades to their homes. Finally, we emphasized the management of controllable operating cost. Even with all of these projects underway, controllable cost were about \$822,000 under budget for the year placing the cooperative in a much more advantageous financial position than at the end of 2009.

## IN THE FUTURE ...

In 2011, we will complete the aforementioned metering system upgrade and construct the second of four new distribution substations across the Tipmont electric system. Our operations staff will continue to target upgrades to equipment in areas of our system that have demonstrated reliability issues. To make sure we can meet our goals in these areas, we will develop a new fouryear construction plan and secure RUS financing. A cost of service study and subsequent redesign of our current rate structures will be completed. We will expand our energy advisor program, continue to look for ways to incentivize member driven energy efficiency efforts, and expand incentives to our commercial and industrial members. The construction-based items I previously mentioned are primarily physical, foundational elements that will eventually allow us to offer members better service. When we sit down in 2012 to finalize elements of the 2013 – 2015 strategic plan we will change from a "physical build" mindset to a more visionary mindset. In other words, once we have the elements in place to insure our members have reliable service and up-to-date systems, we can begin to look at ways to use those physical elements to offer members useful services and tools to manage their energy usage. As always, we look forward to working with you, our members, in the upcoming year!

## BOARD MEMBER RETIRES

# Hathaway retires after 30 years on Tipmont board

A lot can be learned from those ahead of us on life's path, believes Brent Bible, president of Tipmont REMC's board of directors. He knows, because he's been learning from fellow board member Joe Hathaway, who has tallied 30 years of service to the electric cooperative.

With retirement from the board on Hathaway's horizon, he's looking forward to more time to garden and longer visits to Florida, and Bible is expressing the value of Hathaway's tenure.

"Joe has been a mainstay in the Tipmont family nearly as long as I have been alive," Bible said. "His years of experience have been a tremendous resource for younger board members such as myself, as he is able to provide invaluable historical perspective on issues as they come before the cooperative."

Hathaway's commitment remained a top priority over the years, Bible said. "Joe has performed in his last year with the same level of enthusiasm as in his first. His willingness to question the status quo and encourage improvement will be greatly missed by the rest of the board members."

During his tenure that began March 9, 1981, Hathaway's service included 20 years as Tipmont's representative on the Wabash Valley Power Association board, 16 years as board secretary/ treasurer, and, currently, vice president of the board.

Changes in the electric utility industry have been vast in the last three decades, Hathaway said. "I've seen growth in electric use, new rules and regulations, doing away with nuclear power, and now we're likely moving away from baseload coal fire generation."

Tipmont Chief Executive Officer Tim McCarthy hailed Hathaway's service. "Joe has served the cooperative and the membership well, and he has been dedicated and diligent in his duties as a director. We wish him the best in his retirement years."

Born in Danville, Ill., Hathaway was a child when his family moved to Kingman, Ind., in 1943. He went on to earn a bachelor's degree in accounting at Indiana University. He also earned the Credentialed Cooperative Directors Certificate and the National Rural Electric Companies Association Certified Director diploma.

Hathaway served in the Korean War as a navigator for the U.S. Air Force; he continued in the reserves after the war, earning the rank of captain.

From 1963, when he bought land several miles south of Veedersburg, until 1992, Hathaway farmed about 1,500 acres, raising hogs and cattle early in his career.

Now, his sons, Scott and Randy, both Purdue University graduates, farm the ground. "I wanted them to be doctors. lawyers or something famous, but they came back to the farm," Hathaway said. "Today, Scott has a lot of cattle—purebred limousine and Randy has his fingers in everything but livestock."

Farming was a good choice, Hathaway said. "I liked being my own boss, making my own management decisions, assuming my own risks. I loved to get up every morning and go to work."

On board meeting days—once a month each for Tipmont and Wabash Valley Power—he often turned to his wife, Alice, to cover for him on the farm. "I couldn't have done it without my sweetheart of 55 years," he said. "Many times after she retired, she'd take over running the augers and directing the semis so I could go to the board meetings."

Today, the couple winters near Ft. Myers. The rest of the time they're on the farm. "I have a nice organic garden," Hathaway said. "I grow just about everything but broccoli and cauliflower."

They also enjoy their grandchildren and great-grandchildren.

"I've really been blessed," he said. "Life has been wonderful."

## MINUTES

The 70th Annual Member Meeting of Tipmont Rural Electric Membership Corporation was held at Lafayette Jefferson High School, 1801 S 18th Street, Lafayette, Indiana, on Saturday, August 7, 2010, at 9:30 AM. Registration began at 8:00 AM.

Prior to and during the registration period, members were encouraged to visit various Tipmont REMC displays and information centers. Registration drawings were conducted during registration. Five electric credits in the amount of \$50.00 and five in the amount of \$100.00 were given. Tipmont REMC journeyman lineman presented the Live Wire Safety Demonstration during registration.

Each member registering received, an ink pen, a reusable bag, CFL bulb, two Energy Advisor brochures; 'Old washers agitate your clothes. Especially your pockets,' and 'Maybe it's time to upgrade your heating systems,' other brochures included were 'Your fridge needs a retirement plan,' 'The cooperative difference' '101 Easy ways to save energy and money' an information sheet listing the candidates, a Tipmont REMC glow in the dark magnet, comment sheet, an agenda of events card, three 'submit your question' cards, two voting ballots, a letter from the CEO and the Annual Report which included the 2009 Annual Meeting minutes. The annual meeting registration card was mailed prior to the meeting.

Vice President Curt Hudson announced the registration drawings and explained the new process of submitting a question during the meeting.

President Kennedy announced that we had a quorum and called the meeting to order at 9:35 a.m.

President Kennedy introduced Tipmont REMC Manager of Technology and Communications Corey Willis who gave the invocation.

A recorded version of the National Anthem was played.

Secretary-Treasurer Brent Bible read the official notice of the meeting and led the Pledge of Allegiance. He then asked those members present to refer to the minutes of the 2009 meeting, which were given to them at the time of registration. Secretary-Treasurer Brent Bible asked for a motion to accept the minutes as recorded. A motion was made by member Tom Moran and a second made by Lloyd Leamon. The motion carried and the minutes from the 2009 meeting were approved as presented.

CEO McCarthy introduced special guest and Attorney Jeff Helmerick.

Attorney Helmerick introduced the Credential and Election Committee which consisted of Mel Spitznagle for District 2, Chris Benner for District 6, and Edward Crumrin for District 8.

Attorney Jeff Helmerick introduced director candidates Dan Haan and Kirk Alter for District 1, Bill Kennedy for District 3, and Jerry Peevler for District 7. Each candidate was given the opportunity to speak. All candidates addressed the membership except Director Bill Kennedy and Director Jerry Peevler who were unopposed.

Attorney Helmerick then instructed the membership to vote for District 1 using the yellow ballot. He then called for the Credentials and Election Committee to collect and tally the ballots. The Credentials and Election Committee had previously met before the meeting started at the location of the Annual Meeting.

CEO McCarthy commented on the letter that was included in the registration bags.

CEO McCarthy introduced Dean Zimmerman with EnviroWatts who presented a special certificate to Sequoia Bible of Tippecanoe School Corporation.

CEO McCarthy introduced guest speaker Maureen Ferguson, a lobbyist from Indiana Statewide Association of REC's. CEO McCarthy introduced the question and answer session by recapping the new process. President Kennedy, CEO Tim McCarthy and Maureen Ferguson responded to selected questions of general interest submitted by the membership.

Attorney Helmerick announced the results of the election. Kirk Alter was elected director for District 1. With no opposition, Districts 3 and 7 ballots were not tallied. A motion was made by member Christina Gilliland and a second made by Tom Moran. The motion carried and District 1 would be represented by Kirk Alter.

President Kennedy introduced the annual meeting committee. He thanked the employees and the committee for their work.

Director Hudson again announced the winners of the registration drawings, he then asked the winners of the next drawings to come forward to have a photo taken. He then conducted the drawing for the cash grand prizes of \$1,000, \$2,000 and \$3,000.

President Kennedy asked the membership to put their comments sheets in the blue buckets as they exit the building.




